## Patient information on data protection

Dear Patient,

the protection of your personal data is important to us. According to the EU General Data Protection Regulation (GDPR), we are obliged to inform you about the purpose for which our practice collects, stores and forwards data. This information also tells you what rights you have in terms of data protection.

2. Purpose of data processing

Data processing is carried out on the basis of legal requirements in order to fulfill the treatment contract between you and the Ökumenische Kinder- und Jugendförderung and the associated obligations.

For this purpose, we process your personal data/that of your child, in particular health data. This includes medical histories, diagnoses, therapy suggestions and findings that we or other doctors collect. For these purposes, other doctors or psychotherapists with whom you/your child is being treated may also provide us with data (e.g. in doctor's letters).

The collection of health data is a prerequisite for your treatment/the treatment of your child. If the necessary information is not provided, careful treatment cannot take place.

3. Recipients of your data

We only transfer personal data to third parties if this is permitted by law or you have consented. Recipients of your personal data may primarily be other physicians/psychotherapists, the Association of Statutory Health Insurance Physicians, health insurance funds, the Medical Service of the Health Insurance Funds and the billing centers of the health insurance funds.

The transfer is primarily for the purpose of billing for the services provided to you/your child and for clarifying questions arising from your insurance relationship.

In individual cases, data is transferred to other authorized recipients.

4. Storage of your data

We retain personal data only for as long as is necessary for the performance of the treatment.

Due to legal requirements, we are obligated to retain this data for at least 10 years after completion of the treatment. According to other regulations, longer retention periods may apply.

## 5. Your rights

You have the right to obtain information about the data concerning you/your child. You can also request the correction of incorrect data.

In addition, under certain conditions, you have the right to have data deleted, the right to restrict data processing, and the right to data portability.

The processing of your data is based on legal regulations. Only in exceptional cases do we require your declaration of consent. In these cases, you have the right to revoke consent for future processing.

You have the right to complain to the competent data protection supervisory authority if you consider that the processing of your/your child's personal data is not lawful.
